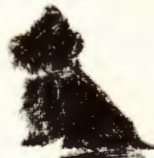
There was an assortment of trophies such as silver plated pitchers, The Heart of America Scottish Terrier Club Cook Book and cash prizes.

It is with sadness and regret that I announce the death of Ch. Anstamm Happy Venture on August 13, 1979, just three months short of his ninth birthday. "Murry" as he was known to his many friends and supporters.

He was a standout puppy and one that matured early, winning several Best of Breed from the puppy class. During his show career he collected over 100 Best of Breed, including 10 Specialty Breed wins, and many Group firsts. Although never a Best in Show winner, himself, many of his get have been Group winners and five of these have gone on to collect the red, white, and blue BIS rosette on more than one occasion. They are: Am. and Cana. champions Anstamm Happy Emigrant and Anstamm Happy Paw Paw, both in Canada, and champions Dunbar's Distinction, Sonata Serenade, and Anstamm Happy Sonata, here in the States. Happy Venture was also a Lloyd Trophy winner and the sire of another Lloyd winner, Anstamm Happy Sonata, making three successive generations of Anstamm Scotties to receive this award.

Like his sire, Dark Venture, and his grandsire, Bardene Boy Blue, Murry could always be counted on for a "heads-up, tails-up" ring performance. Although he had his father's sometimes overly competitive nature in the ring and often livened up an otherwise sluggish specials class, he genuinely loved people and would melt like soft butter around children. He was generally well received by breeders, handlers, and judges alike and was fortunate in having many good bitches sent to him. This fact plus his ability to pass on his good qualities with great consistency combined to make it possible for him to set a new record as the breed's all-time top producer of champions. Currently, he has sired 65 champions, and there are easily more than a dozen who should complete their titles. He needs only a few to become the all-time Top Terrier Producer, and in the books of the various systems keepers, he is on record as a top producer, all breeds.

Happy Venture lived up to his name in every way. He was indeed a happy dog and enjoyed his years at Anstamm, greeting the many visitors who came to see him; racing across the spacious back lawn and up and down the big hill; playing furiously with his yellow plastic football; savoring the grequent house (and bed) privileges, which he liked more than anything else; and, of course, servicing the visiting bitches that came to him from time to time. He was very special to me and enriched my life in many ways, bringing me much happiness, pride, and pleasure in his ring accomplishments and those of his offspring; in the records he set; and in the simple enjoyment of his companionship and sweet nature. He is gone now, but he leaves a legacy of happy memories that will not soon fade and a 3-week-old litter of five black, bouncy boys, at least one of which I hope may someday "Venture On" where he left off.

VON WILLEBRANDS DISEASE AND THE SCOTTISH TERRIER

The following is based on data supplied to the S.T.C.A. for reprint in the Bagpiper.

It is important to all Scottish Terrier Breeders, whether you feel your stock is clear or not. For those of us who have seen the problem since the early Seventies, without knowing what it was or having a solution for same, it has come not a moment too soon. For those of you just finding it now, be thankful that it is a problem which can be bred out within two generations, with prudent breeding and all-inclusive testing.

VWD (von Willebrands Disease) is an inherited bleeding disorder which occurs in man, Poland-China swine and dogs. It has been recognized to date in six breeds of dogs, one of which is the Scottish Terrier. Individual cases have also been recognized in other breeds. The condition occurs in both sexes and is inherited as an "autosomal incompletely dominant trait.... a trait of variable penetrance."

This means that it affects both sexes equally and can be transmitted by single parent which has the defect. The presence of the trait can be detected by special blood tests of Factor VIII activity and antigen. The availability of these blood tests makes it possible to eliminate VWD from a line by testing all individuals before they are bred and not using those which prove to be affected.

VWD resembles hemophilia and has frequently been confused with it in the past. Hemophilia (an X-chromosome-linked recessive condition) usually only affects males and is transmitted only by females.

VWD is characterized primarily by prolonged bleeding time or excessive bleeding when nails are cut too short, severe bleeding during surgery, bleeding from the nose or gums (usually in teething puppies), from the vagina or penis, hematomas on the surface of the body, limbs or head (and internally), lameness from joint or limb bleeding, stillbirths or neonatal deaths with evidence of hemorrhage at autopsy, chronically infected and bloody ears, prolonged bleeding from the vagina during heat cycles or after whelping. Fresh blood in stools, blood in urine or excessive umbilical cord bleeding at birth are other problems that can occur in affected dogs.

It can only be distinguished from hemophilia through these specialized clotting tests and a thorough family study. Affected VWD dogs usually have long bleeding times and abnormal results in specific tests that measure the Factor VIII complex (factor VIII activity and antigen, and platelet-related von Willebrand's factor). Carrier VWD dogs show reductions in one or more of these clotting tests.

WHAT THE TEST RESULTS MEAN: Factor VIII (FVIII:C) - normal range 50 - 200%. 50 - 60% FVIII:C is low normal Factor VIII-Related Antigen (FVIII:RA) normal range, 60 - 172%. As the assay for FVIII:C is usually normal in all carriers of VWD and may or may not be significantly reduced in affected animals, we no longer routinely measure FVIII:C levels. The critical test for assaying for both the affected and carrier states is currently the FVIII:RA test. New tests for platelet-related von Willebrand's factor (VWD) are being developed to be used in addition to the FVIII:RA assay. These may help to clarify the status of dogs testing borderline (low-normal).

Dogs with factor VIII antigen levels of 90% or greater are considered high-normal. Dogs with antigen levels of 60% or greater are considered normal. Dogs testing between 60-70% for FVIII:RA are at the lower limits of the normal range. The division between normal, low-normal and carrier ranges is merely arbitrary, based on our cumulative experience with over 2,000 dogs. Remember, therefore, that there may be some overlap of these categories in a few cases. Thus, you should plan your breeding program to select away from the VWD gene, i.e., breed dogs testing at the lower end of normal range to high-normal, if possible, This is an important general recommendation, that cannot be stressed too strongly.

Dogs with antigen levels between 50-60% are equivocal, not high enough to be normal or low enough to be called carriers. These animals are classified as low-normals but some can be carriers. Dogs testing in this category are possibly or probably normal depending on their clinical histories and relationship to known affected or carrier dogs. As factor VIII levels tend to increase with age and multiple pregnancies, older carrier bitches that have had several litters may test as low-normal or even at the lower limit of normal range (FVIII:RA between 50-70%). Thus carriers may test as borderline. By contrast, some dogs with two normal parents may test as low-normal, these dogs are thus probably normal, as opposed to the dog from known affected or carrier parents, who is probably a carrier if he/she tests in the low-normal category. This is why a thorough study of the family is so important.

Dogs with antigen levels of 50% or less are considered to be carriers. Carriers can be mild (40-50% FVIII-RA); moderate 20-40% FVIII-RA) or severe (less than 20% FVIII-RA), depending on their levels of antigen. Some severe carriers have been reported to be mild bleeders.

Dogs with Zero level of antigen are affected with WVD. The great majority of these dogs are clinically affected bleeders. Over 30 bleeders have been identified to date without counting those dogs known to have bled to death or to be bleeders and not yet tested.

Of the more than 600 Scotties tested now, approximately one-third test as carriers and about five % are bleeders. (Dr. Dodds feels that the prevalence of the carriers and affecteds, which constitute 37.5% of those tested as of February 14, 1979, is disturbingly high.)

Because WVD is less severe and occurs in both sexes, the incidence increases rapidly within affected inbred lines. Therefore it is very important to test dogs that are closely related to a line affected with WVD, in order to prevent the widespread dissemination of the disease.

ELIMINATING WVD: The recommendations are to eliminate both affected and carrier dogs from the breeding pool. It is felt that, if these recommendations are carried out WVD could be eliminated from the breed in two generations. However, it should also be pointed out that you may not have to abandon your current breeding program because you have dogs testing as carriers.

THESE ARE BASIC STEPS SUGGESTED BY DR. DODDS WHICH YOU CAN FOLLOW:

1. Never breed TWO CARRIERS, as $\frac{1}{4}$ of the litter can be severe bleeders.
2. Never breed to a dog of inferior quality just because he tests at 200.
3. Never breed TWO AFFECTED DOGS as the entire litter should be affected or die in utero.
4. Never breed a SEVERELY CLINICALLY AFFECTED BLEEDER. (Too risky, bitch might need C/Section)
5. Breed carrier dogs ONLY IF ESSENTIAL TO PRESERVE YOUR BLOODLINES and ONLY TO NORMAL DOGS. preferably testing HIGH-NORMAL for added protection.
6. Don't breed a Carrier of Inferior Quality. Sell as pets or keep as pets yourself.
7. IF you breed a CARRIER, the pups should be tested for WVD at 10 weeks or later. $\frac{1}{2}$ of the litter should test normal; the other half should test as carriers, like their carrier parent. The normal pups will provide you with bloodlines you need to continue breeding CLEAR STOCK.

WVD, as previously stated, is inherited from a gene that is incompletely dominant. According to classical autosomal inheritance, if ONE parent is affected or a carrier, the chances are that $\frac{1}{2}$ of the litter will be AFFECTED or CARRIERS, whereas $\frac{1}{2}$ will be NORMAL. If BOTH parents are AFFECTED or CARRIERS, $\frac{3}{4}$ of the litter will be ABNORMAL ($\frac{1}{4}$ severely affected and $\frac{1}{2}$ MILDLY AFFECTED or CARRIERS.) ONLY $\frac{1}{4}$ Will be NORMAL and often this mating is lethal to some of the embryos or newborns.

The actual incidence of AFFECTED OFFSPRING within any one litter, however, does not necessarily fit the statistically expected ratio of affected to normals.

WHAT ABOUT THE PET SCOTTIE: Realistically, it should be tested too, although it may never be used in a breeding program. Too often, a bitch being spayed, a dog being neutered or a pet just in for minor surgery, has bled profusally, gone into shock and died. Even something so minor as nails clipped too short or a cut so small that you cannot readily find it, in the Scotties' long coat can spell death for the bleeder with ZERO antigens. You have about 45 minutes to get that dog to the Veterinarian for treatment. Far better to have tested your Scottie so that your Veterinarian can be on the alert for unusual bleeding times.

A WORD TO THOSE BREEDERS WHO FEEL IT IS NOT NECESSARY TO TEST BECAUSE THEIR LINE IS RELATIVELY CLEAR OF WVD. You, along with the rest of us, as caretakers of this special breed, have a moral obligation to test and if your stock proves clear, to publish those results. Information on good, top producing stock, which tests high, is of paramount importance to current breeders, especially the newer ones. Many may have to look to YOU for new breeding stock. Without the co-operation and integrity about testing for WVD, we cannot hope to eliminate this gene from the breed. With total co-operation we can be free of it, in one or two generations.

This article was originally written for the STCA Column in the AKC Gazette, July 1979. I have added the paragraph on Pet Scotties, as I feel it will be of value to those members and owners who do not breed.

FURTHER INFORMATION ON VON WILLEBRANDS DISEASE AND THE SCOTTISH TERRIER

The following information should be helpful in explaining the current data on the prevalence of the WVD gene amongst Scotties plus how they arrive at the normal range. This information was supplied by Dr. W. Jean Dodds at my request after her talk at the STCA dinner, held in New England on June 2, 1979. Many of those present seemed confused and it is my hope

that the following will clarify any misunderstanding about the testing program, which may exist.

As of July 1, 1979, 1079 Scotties have been tested for the VDW trait. Those carrying the gene for WVD have it expressed as: REDUCED PLASMA FACTOR VIII-RELATED ANTIGEN and/or von WILLEBRAND'S FACTOR ACTIVITY. In nearly all cases studied to date (35 Scotties), dogs affected with WVD are the progeny of two carrier parents, i.e. affected bleeders apparently have a double dose of the WVD gene, one from each parent. They are HOMOZYGOUS for the trait.

The carrier, on the other hand, has only one dose of the gene and is HETEROZYGOUS for the trait. They are ASYMPTOMATIC - do not show any clinical signs of bleeding tendency.

It should be emphasized, however, that this autosomal recessive clinical expression of WVD applies only to Scotties, some human families and to the Poland-China swine family with WVD. The other five breeds of dogs and the majority of human families known to have WVD have an autosomal dominant clinical form of WVD in which HETEROZYGOTES can be either ASYMPTOMATIC CARRIERS or CLINICALLY AFFECTED with WVD to a varying degree of severity. Thus, although WVD is still detected as an incompletely dominant trait by laboratory testing of the plasma of affected families and their relatives, the clinical expression can either be RECESSIVE, as in Scotties, or DOMINANT as in the other affected dog breeds.

NORMAL RANGES FOR FVIII-RA IN DOGS: The original normal range determined for dogs by the laboratory was 68-172%, and was arrived at by comparing the antigen levels of 20 healthy young adult dogs (10 of each sex, bitches not in estrus or pregnant.) with that of a standard reference plasma made from pooling equal volumes of plasma from each of the twenty dogs studied. This pooled standard reference plasma was arbitrarily assigned a value of 100% for FVIII-RA. A fresh batch of plasma from 10 of these 20 dogs (5 of each sex) is prepared every 2-3 months and frozen at -70 degrees C. to serve as our internal standard for test samples. Each new batch of standard plasma from those same dogs is compared to the previous batch to ensure that results obtained new are comparable to those obtained last year or next year.

On each plate run for FVIII-RA (we saw these being processed) the pooled standard reference plasma is run in three dilutions and then at one or two other random spots on the plate to ensure even distribution of measurements across the plate. Results for test samples are considered valid only if the standards on the plate read within 5% of each other and provided that the values for the test sample agree within 10-12% at two different serial dilutions.

Now back to the normal range! Another 10 healthy normal dogs of mixed and random pure-breeds (5 of each sex) were studied and the range was found to be 60-172%. Then, more recently, we expanded our study of normals and included 58 samples being shipped in for routine testing. These came from healthy purebred dogs of breeds not currently known to carry WVD and included 57 males and 31 females. The mean \pm 30% or a range of 60-123%.

We were pleased that the lower limit of this range was also 60% and concluded that this appeared to be the best measure we had of the lower limit of normal for most, but not all, normal dogs. Of the 58 recently studied normals, five had antigens below 60%. One of these was 46% and the other 4 tested in the 50's. So-- a few normal dogs can test below 60% (Between 45-60%) but the great majority test at least 60%. Similarly, at the other end of the scale, some normal dogs can test above 172%, and some carriers of WVD can test above 50%. We know of three proven carriers of WVD (have produced affected or carrier pups) whose antigen levels were between 50-73%. These include bitches which have had several litters and an old stud dog, -- both factors which could explain their higher readings. Three other older, multiparous bitches which originally read between 64-82% have been retested and levels were between 30-39%.

So -- it was decided to analyze the existing data from Scotties where both of the parents had been tested. There are 348 dogs in this category at present. Because a few known carriers tested between 50-70% for antigen, it was arbitrarily chosen to look at those dogs whose parents tested 70% or higher (to minimize the possibility of carriers being included in this group). There are 59 dogs in this category. The data on the demographics of these normal Scotties (based on their having two parents testing 70% or better) showed that four of them tested less than 50% (1 at 46%; 3 at 45%) and presumably were misclassified. Two of these have the same sire and two of the dams are half-sisters. However, the majority of the offspring of 2 normal parents tested normal, which attests to the reliability of the FVIII-RA assay as a monitor of the WVD trait in Scottish Terriers. The fact that apparently 4 animals were apparently misclassified by this assay as carriers instead of normals is a small number of the total and is not unusual for biological assays which are used to monitor genotype.

I am sorry to have missed out on the last two issues with my report as I feel I have let down your editor who does such a wonderful job in filling each issue so regularly, but over the last year I have been committed to writing some ten booklets on specialised philately subjects which has meant a great deal of research and in a number of them numerous drawings, then we had our severest winter in living memory, at least in the village where we live on the edge of the Downs (temperatures were down to minus 20°, unheard of even in what we normally call a very "severe" winter) which led to frozen pipes which we luckily managed to get repaired within 24 hrs. only to be frozen up again twelve hours later! We managed to get someone in to trace the cause of the trouble and it was finally found to be two feet of exposed piping into the roof eaves, by which time there was no pipe logging to be had for 50 miles around. We had just got over the strain of all this when my wife and I attended a Scottie Championship Show within 48 hours we were down with a most virulent influenza - some new strain - we both felt really awful but with 7 dogs had to keep going. The after effects were probably worse than the actual flu - depression! It turned out that someone attending this show was a prime carrier as we later heard of over 25 people who were ill after the show including Nellie Holland, Secretary of the Rescue Scheme (S.T.E.C.S.) who was very seriously ill for three or four days and should have really gone to the Hospital but she would'nt leave her dogs. I am glad to say she made a good recovery since her condition was correctly diagnosed. Nellie had previously been very busy as 1979 started off sadly for the Rescue Scheme with four rescues in one week in January and six in ten days in late February, pushing up the then total number since 1-7-1976 to 52 rescues, it is over 60 as I write.

These rescues not only proved twice as difficult as normally because of the weather but the terrible strikes we had in many main services actually caused food shortages in certain areas, such as tea and sugar, dog biscuits and meal etc. She had to actually kennel some herself for weeks on end because roads were impassable, council workers were on strike and no roads were gritted against the frozen ice; our car was immobilized for a week because we have a slope up out of our drive and the side road we came out onto was a pack of ice, only farm tractors could move on this surface and they merely packed it tighter.

It is strange but throughout S.T.E.C.S. existence, just over three years now, rescues have always come in bunches, so much so that after, say a break of a month or two Nellie almost dreads the phone ringing with a "rescue" as it seems bound to be one of a number - only recently it was again seven in fourteen days, all of which have been placed except a wheaten dog three years old, but we are hoping to find a home for this as I write my report.

The four in January included two 8 year litter brothers who had been inseperable all their lives but were taken to a Vet's to be "put down" because the daughter of 8 years was allergic to dog hair! The Vet made enquiries found that they now had a Bull Terrier for breeding (no doubt with non-allergic hair!!) He refused to put them down as they were in good health and the prime of life as he said and contacted us. It was no easy task to find a home for two 8 year old dogs as Nellie had decided they must not be separated if it was humanly possible but in ten days we found a marvellous new home for Willie and Tuffie with someone who had had Scotties for nearly 40 yrs. Another rescue was a bitch we called "Growly" because she didn't seem to like children (no doubt had been ill-treated by one in the past) Nellie kept her three weeks and completely gained her confidence and she proved a happy little soul but it took three homes before we found some where that she settled in happily.

These two cases were probably the most difficult S.T.E.C.S. has had to deal with so far but it shows that nothing is impossible where finding a home for a Scottie is concerned, it just takes time and patience in difficult cases.

Now S.T.E.C.S. is firmly established we are honored to have as our first President Mrs. Dorothy Standen, whom many of you will know for her famous Tambræe breeding. With our new Treasurer John Donoughoe and an Asst - Secretary in charge of fund raising - Lillian Bailey - S.T.E.C.S. now has a marvellous team and results are already beginning to show on the financial side from their ideas and fund raising activities.

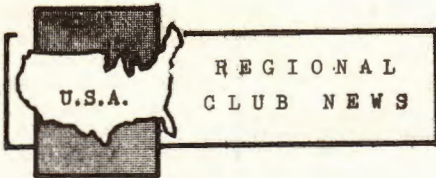

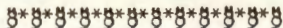

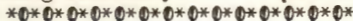

There was no such number. She then checked the address, again it was non-existent. On Monday she started to call all pet stores in the Baltimore area. And after calling many and asking for Harry Schwartz, at the Security Mall Doctor Pet Center the person who answered the phone said, "He is not in now". Mrs. Jones hopped into her car and went over to the store and, there in one of the cages, was her puppy, priced at \$300. Mr. Schwartz was there. She said she wanted her puppy back and she would give him his money. He said she had to leave the store or she would be arrested. Mrs. Jones went home and called AKC and the Baltimore County State's Attorney. In one half hour Mr. Schwartz told her to come and get her dog. When she picked up the dog he said

he didn't usually use his right name.

I feel my friend did a super job in tracking down the puppy. All local kennel clubs are being notified of this incident and so are the local newspapers.
