Report of the President:

- Thanked everyone for coming to the meeting and the weekend events
- Also wanted to thank Pat Wooster and Ron McConnell for their service to the Board as they are retiring this week.
- Looking at AKC registrations (both litters and individuals) and the numbers continue to slump.
- Three areas will be the focus of the year: Education (judges and members), Health, and Regional Clubs

Motion: To amend the agenda to reorder it to allow Executive Session topics to be back to back. LHills/PWilliams. Passed unanimously

Motion: To amend the agenda to combine discussions of Health Trust Fund documents and election of Trustees to be back to back. LHills/PWooster. Passed unanimously

Treasurers Report

Steve Russell

Financially, in 2021, the Club recorded its record 11th year of operating in the black.

- During the last 12 months (from October 2021 through September 2022), the Club has operated on Income of \$122,574 and Expenses of \$105,380 with Net Income of \$17,195. The Balance Sheet currently shows Net Assets of \$525,146 up 3.3%.
- The most noteworthy differences in year-to-year comparisons (+/- \$1,000) include:
 - Rotating & Montgomery National Specialties income and expenses are both higher as operations returned from the pandemic.
 - The Board continued to subsidize member participation in these national events at a loss of \$4.9k.
 - The Members continued to donate generously \$4.8k to offset Trophies
 & Specialties expenses.
 - Shoppe sales continued increasing to \$14k with increased sales of grooming merchandise (up 17%) and the addition of new clothing designs.
 - Investment returns are up 5% and deliver projected annual income of \$8.6k.
 \$25k in surplus cash was transferred to investments concurrent with the April re-investment period.
 - Bagpiper costs increased \$2.6k (8%) due to increase cost of production and ad revenue not yet returning to historical norms. Reductions have been made to the number of pages and distribution, but the magazine operates at a loss.
 - PAWS donations were up \$2.8k due primarily to a \$2k bequest from the Sarah Lane Flake Estate.
 - Awards costs were up due to replenishment of Bred-By Exhibitor Medallions.
 - AKC income increased \$1.6k with a stipend for Meet the Breeds which was transferred to the Regional Clubs hosting the events (Tampa & Dallas). AKC Club Flyers were sent to 1,710 newly registered Scotties.
 - Membership continues its slow downward trend with another -2.3% net decline in revenue.
- Year-to-date, at this interim point in time in our operations, the Club is operating on a loss in Net
 Ordinary Income of -\$16,230. As usual, the Club is dependent on positive results from
 Montgomery, Bagpiper #4, and Membership Renewal to offset this loss before year-end.
- A significant bequest of \$3,696,328 was received by the STCA Health Trust Fund, from the A. Foster Cooper Estate. Working to determine the appropriate tax reporting.
- The Law Office for Fran Garb (member) assisted filing the 2022 Annual Report certificate for incorporation with the state of New Jersey;
- The accounting firm of Hague, Sahady, & Company (Mary Sahady CPA MST is a member)
 assisted filing the 2021 Tax Returns with the US Treasury and I have paid the quarterly taxes due
 for Unrelated Business Income (interest on investments);
- Nat Kramer, an attorney with the firm of Kirschstein, Israel, Schiffmiller & Pieroni in New York, assisted filing the once per decade renewal of STCA's logo trademark registration with the US Patent Office; and
- Insurance Policies for liability are in place for the Club, Officers, Awards, and Fidelity Bonding and premiums have been paid annually.
- As always, the STCA's books remain open. Members can see monthly Statement of Financial Position (Balance Sheet) and Statement of Financial Activities (P&L) uploaded to the STCA website and published quarterly in the Bagpiper magazine.
- There were 929 members who renewed their dues for 2022 (a decline of 5.8%). Preparations are underway to start 2023 Membership Renewals at Montgomery. Collections will begin with 770 households and 980 members. A Board approved change has been made to require all members move to First Class USA Postage and pay the \$20 fee to help offset Bagpiper costs.
- The cost of producing the Bagpiper magazine has gone up to ~\$10/issue or \$40 per year (a ~\$10,000 loss so far this year), which exceeds the monies collected from Dues.
- We have been unsuccessful in seeking Club members to assist or replace the Treasurer and Tax accountant. This may require additional outsourcing at a fee.

Montgomery Week Update

- Tents have been slightly relocated to create better access and more grooming extra tent outside ring for our use. Donuts and coffee will be brought in for exhibitors.
- Montgomery County Kennel Club has a contract with Macungie for 5 years to hold shows at that site. Hatboro will most likely remain there as well.
- Our contract with the Sheraton in Bucks County runs through 2023. Many members have approached the Board regarding the distance needed to travel between the two. STCA Board is looking at options.
- Request for Lloyd Trophy to be taken to Montgomery County for photograph. After much discussion, it was felt that as it is not specifically related to the Montgomery County/STCA National Specialty show, it would not be taken to show site.

Motion: STCA will no longer have the Annual Awards on display at the Montgomery County Kennel Club/STCA National Specialty show. KFerris/HPrince. Passed with 10 votes and one abstention.

Motion: STCA will have a professional photographer photograph the Lloyd Trophy to be available to the current and past winners. KFerris/PWilliams. Passed unanimously

Rotating 2023 and 2024

 - Need details on financial responsibility split between STCA and STC Tampa Bay

AKC Delegate

- Full report from past several months has been published in The Bagpiper
 - Fourth attempt to limit terms of AKC Board members failed
 - Approved awarding AKC Championship points to all Class dogs in Group Placements
 - Is AKC really serving the STCA well? There is a growing sense that it is not and we will need to address this is in the future.
 - AKC Semen Preservation Bank investigating whether or not this idea should be pursued.
 - Need to develop guidelines
 - Deeding semen to bank in wills and estate plans
 - Dr. Bell is writing up report on subject

Reports of Standing Committees

Approval of all reports not requiring action at this time.

Motion: To accept all Reports net requiring action or review at this time. LHills/KEdell. Passed unanimously

- Committees requiring discussion/action:
 - Breeder Referral needs some additional oversight
 - Judy Shaffer will now handle inquires west of the Mississippi River, and Tambre Knox will continue with those inquires east of the river
 - Website needs to be updated few people actually use that portal
 - Will also include placement of older dogs, not just puppies
 - Ongoing frustration members aren't returning calls when contacts are made
 - Potential article in <u>The Bagpiper</u> to help with process
 - A Board liaison will be appointed on Friday evening
 - Education Judges & Member

- This is an important initiative for the coming year- members, breeders, and judges are all to be included
- Establish a panel to ask judges they are seeing in the ring, are the dogs meeting the standard or are we just seeing differences in style?
- Need to further explain the breed specific judging for the Scottie
- Focus Regional Club grants on educational efforts, not more grooming seminars
- Become a resource for newcomers, demystifying the breed, grooming, and presentation
- AKC is asking parent clubs to film judging
- Establish three committees:
 - Judges Education KHill, KEdell, JJones
 - Breeders Education Mkrolowski, HPrince, RBumstead, SRussell
 - Breed Education PWilliams, LHills, KFerris
- Legislation Update
 - Not a lot going on at the moment, but there is one movement we will need to track: a state requirement that anyone paid to 'train' a dog must be accredited by one particular organization. Unclear what the parameters are or enforcement.
- Membership current applications
 - Lisa Hills will be stepping in to take over more of the process to help Kelli Edell
 - Currently there are 2 applications in process and just received 3 more
- PAWS for Juniors
 - Sueannette Maniscalco will be ordering new pins as a fundraiser. Under \$500 coast so no board approval required.
 - Junior Showmanship pamphlet needs to be updated
- Pedigree Database
 - Need to identify a back-up staff member to help as needed
 - Need to have the process documented for future generations
 - Current web technology doesn't accommodate searching on a phone very well
- Tallies Staffing, Procedures
 - Need more help in keeping this current most time is spent verifying ownership issues
 - MKrolowski has documented his process
 - JJones will be assisting as needed
 - LKelly will ask for additional assistance in the next Wrap Up
- Website Member's Only Section, Updates, Historian
 - Need to reset photos for a refresh
 - What should be in the Members only section? Is this a real benefit of being a member?

 - o Proposed to add the following point at Paragraph 7a:
 - To establish a financial advisory committee (minimum of 3 people) to review investment strategies
