Treasurers Report

- Financial Reports the club has recorded a Net Income loss of \$2,986 on high transaction volume as we near the Montgomery 2022 deadlines. This brings the Club's YTD Net Income loss to \$7,955. The Club's Balance Sheet Net Assets stand at \$533,425.
- Listed below are the accounts with income and expense over ~\$500 this month.
 - o Income
 - \$4,533 Montgomery 2022 (partial entries & meals ... closing this week)
 - \$694 Shoppe (grooming & other merchandise)
 - Expense
 - \$7,159 Bagpiper 2022#3 (total production \$8,439 for a loss of \$3,569)
 - \$557 Shoppe (2022 commemorative pins inventory)
 - \$430 Taxes (quarterly deposit)
- Other Activities
 - Rotating 2022 We received the profit-sharing payment (55 dogs @ \$3 = \$165) from the Baltimore County KC to close out this year's event. Total Income was \$10,271 and total Expenses were \$13,661 for a loss of \$3,390 on the show.
 - Montgomery 2022 Closing deadlines are this week when a payment of about \$8,000 is due to the host hotel.
 - Bagpiper Much of our YTD loss is attributable to the Bagpiper magazine losing \$10,000 which we have not been able to overcome. Despite reduction in pages and distribution, the revenue generated from ads is not covering the cost.

- Dues remain unchanged. Beginning in 2023, all issues of the Bagpiper magazine will be sent to all members by First Class US Postage. No Bulk mailing permitted. All USA Members are required to pay the additional \$20 along with their Dues.

New Business

- STCCalifornia request for move of date
 Lori Kelly
 - STCCalifornia requested moving their Specialty to the weekend shows during March 3 or June 3. Both dates conflict with current Specialties (March is Heart of America, and June with New England)
 - Need to determine if this is a one-time event or a permanent
 - STCA has a long-standing tradition of not allowing clubs to overlap shows on the same weekend, and we have just recently declined a similar request
 - o Exhibitors often travel great distances to show to judges they like
 - Discussion of why clubs are moving to clusters instead of stand-alone events, usually comes down to financial benefits and lack of club members willing to work on the show
 - The STCA Board needs to address these ongoing conflicts
 - LKelly will reach out to Mark LaBonte to help them work through the issues
